\* One-year extension granted to allow the outgoing President to serve one year as Past President.

\*\* "Ex Officio" members are appointed annually to the Executive by the President for one year terms, renewable annually, and will attend Board meetings as requested. These members shall be non-voting.

The duration of the term of a board membership is three years. The OABP Bylaws state that a board member may serve two consecutive three-year terms (six years in total), then must take a year off the Board before being eligible for reappointment. An approximate "target" has been set to having one-third of the board's terms coming due in a given year, so that continuity can be maintained but always introducing some "new blood". Terms begin/end at Annual General Meeting in November of each year.
